PART IINARRATIVE SUMMARY

Operation KINGFISHER continued through August. The 1st Battalion, 9th Marines remained as the Resident Infantry Battalion at Camp J. J. CARROLL with Companies "A", "C" and "H&S" in the perimeter, Company "B" at Delta-5 and Company "D" at Ba-Long.

Company "A" began eight (8) day search and destroy operation on 2 August northwest of Cam-Lo in the area bounded by grid squares 0563-0963 on the north and 0657-1057 on the south. During the operation over one hundred (100) rocket sites were discovered and destroyed and two (2) one hundred and two (102) millimeter rockets plus various items of individual issue and enemy weapons were turned into Division G-2. Company "A" returned on 9 August.

The Battalion's Civic Action remained in full swing with Medcaps and the use of armed propaganda teams coupled with a leaflet drop for three (3) days in the Bang-Son area. The villages of Cam-Nghia, Cam Chinh, and Mai-Loc were the center of the Medcaps program with over seven hundred and fifty (750) people being treated.

On 14 August Command Group "A" with Companies "A", "B" and "C" (-) began search and destroy operations in the area bounded by 0867-1267 on the north and the Cam-Lo River on the south. The sweep began at coordinates (YD 120662) from east to west discovering many enemy bunkers, eighty-two (82) millimeter mortar rounds and several enemy weapons. After moving to the western boundary the Battalion moved south, blowing in accordance with Battalion policy all enemy emplacements encountered.

On 21 August Company "B" was detached and sent to the Delta-5 area. The next morning they were assigned a new mission below 3/3's position and that afternoon Command Group "A" and Companies "A" and "C" (-) joined them and began a search and destroy operation in the area west of Highway nine (9) bounded by 9652 - 9952 on the north and 9646 - 9946 on the south. During this operation the Battalion was mortared on five (5) occasions and received sporadic small arms fire almost daily. The heavy undergrowth and deceptively steep grades of the mountains made the movement slow and hazardous. This operation concluded on 28 August with the return to Camp J. J. CARROLL.

Camp J. J. CARROLL received approximately sixty (60) one hundred and two (102) millimeter rockets at 310410H August with only minor casualties. The S-1 tent sustained a direct hit and caught fire. Later that day Command Group "A" with Companies "A" and "B" began Operation LIBERTY. Company "C" remained at Delta -5 and Company "D" at Ba-Long.

PART IIISEQUENTIAL LISTING OF SIGNIFICANT EVENTS1. FMF Organizations committed to combat and the SLP.

a. Combat Missions Assigned. The battalion was employed in Operation KINGFISHER and Operation LIBERTY which commenced 31 August 1967. Operation KINGFISHER included two (2) battalion (-) size S & D operations.

(1) Operation KINGFISHER. To occupy and defend Camp J. J. CARROLL and the assigned area of operations to include the defense of Delta -5, Ba Long and the Khe Gia Bridge.

b. Significant Operations Conducted. The Battalion conducted two (2) Battalion (-) S & D operations destroying enemy bunkers and rocket sites, recovering enemy small arms and rockets, and providing security for "Rough Rider" convoys.

g. Equipment. Within this reporting period, organic motor transport has been engaged in household, administration and resupply runs for the Battalion. There is still a serious shortage of M-422A-1 vehicles. At present, the Battalion operates with twelve (12) out of a T/E of twenty (20) "Mighty Kites", the rest being code -X at FLSU. The receipt of four (4) M-37B-1 Personnel Carriers has greatly helped the vehicle shortage problem; however the quality of workmanship of two (2) of these rebuilt vehicles left much to be desired. At present, motor transport is able to adequately perform its mission in support of the Battalion; however due to the shortage of M-422A-1 vehicles this function is somewhat impaired with average deadlines. (ie 10% of the vehicles on hand were deadlined).

h. Logistics. During the month of August logistical activities were centered on resupply to the companies in the field, resupply to Camp J. J. CARROLL and preparation for the Division Supply Inspection. The continuing problem of not receiving all resupplies in the field was investigated. It was discovered that the shortage of helicopters, plus many other commitments, resulted in gear being left on position at the landing zone.

i. Civic Action. Throughout the month of August, First Battalion, Ninth Marines held eight (8) Medcaps in the villages of Cam Chinh (YD 090525) and Cam Nghia (YD 090523). These Medcaps were conducted and coordinated by the Battalion Aid Station and the S-5. A total of 781 indigenous personnel were treated during the month of August and a large quantity of Medcap supplies used.

j. Administration. During this reporting period, the Battalion was the recipient of the Treasury Department's highest award for achieving 90% or more participation in the Savings Bond Program during the time when it made up Battalion Landing Team 1/9. At the present, Battalion participation in the Saving Bond Program is 75%.

1. Intelligence. During the month of August the following enemy units were reported operating in the Battalion AO: elements of the 90th Regiment, 324B Division, elements of the 15th Engineer Battalion, elements of the 29th Regiment 324B Division.

On 4 August Company "A" found one hundred (100) rocket launching positions along with two (2) 102mm rockets intact. Rocket positions were aimed toward Dong-Ha, Cam-Lo, and Camp J. J. CARROLL and were located at (YD 065615,,

On 17 August Companies "A" & "B" discovered an enemy base camp complex which included thirty (30) reinforced bunkers, fighting holes and mortar positions and was located at (YD 095667) and (YD 100667).

On 22, 23 and 24 August Companies "A", "B", and "C" at (YD 966500), (YD 961505) and (YD 965469) captured a variety of enemy weapons including AK-47 rifles and one (1) Chinese Communist light machinegun type fifty-three (53). Several pounds of medical supplies were also found. One (1) NVA detainee was taken and forwarded to the rear for interrogation along with several Chinese maps and captured personnel papers.

In the Delta-5 area (YD 1052) several mining incidents occurred; however no pattern could be determined.

Contact with North Vietnamese Army Units during this reporting period found the enemy making maximum use of mortars and night activities. The enemy was aggressive, well-disciplined and well-equipped. Satchel charges and Chinese Communist grenades were employed extensively against friendly positions.

m. Weather. During this reporting period, the temperatures ranged from a high of ninety-five degrees (95°) to a low of seventy-six degrees (76°). Winds prevailed from the west - northwest providing generally unlimited visibility. In late afternoon increasing cloudiness and showers were common.

n. Communications. Radio communications for this reporting period was reliable. Problems were encountered during Operation KINGFISHER due to interference of the Artillery FDC Net, TACP Air Common, and our Battalion Tactical Net. No two (2) of these stations were able to transmit at the same time because of the closeness of frequencies. Again this month the Battalion was operating on a dangerous close margin due to combat losses (10), and downed radios (21), because of lack of handsets. Presently we are operating on approximately sixty (60%) of the T/A allowances.

The AN/TPS-21 Radar Set performed very well with no breakdowns whatsoever during this reporting period. In comparison with past performances this was remarkable.

o. Fire Support. During the month of August there were a total of one hundred and forty-three (143) artillery fire missions resulting in 13,574 rounds being fired. A total of thirty-nine (39) prep-fires were delivered during the period causing numerous secondary explosions and burning large areas that could have possibly concealed enemy troops. There were eighty-five (85) live targets fired upon with thirteen (13) confirmed KIA's. Spotter rounds, totalling five (5), were fired for location and directional purposes. Counter-mortar fire was delivered from 22 through 26 August silencing enemy mortars before they could be effectively utilized.

On 25 August a total of thirty-seven (37) missions were called while under heavy enemy mortar and ground attack. 3,065 rounds were fired on this date.

p. Air Support. During this reporting period 1st Battalion, 9th Marines utilized both helicopters and fixed wing air support in hostile and non-hostile environments.

Medevacs were successfully completed using both open landing zones and the hoist method when necessary. One (1) medevac helicopter received mortars in the landing zone but departed without serious damage. With the exception of one (1) isolated case, time in completing the medevac was highly satisfactory.

Flareship operations were conducted during bad weather and instrument conditions utilizing TACAN and DMB to make the initial flare drop followed by ground corrections from FAC.

Aerial Observers were used to control ninety-five percent (95%) of the fixed wing air strikes due to their superior visual capabilities. Several air strikes were conducted against enemy fortifications and suspected positions with good results where damage assessments were possible. TPQ's were also used even during bad weather against enemy positions.
