### Special Order 87 (Arrested)

On 12 April 1945, Special Order #87 was published. It placed those who had refused to sign Base Regulation 85-2 under arrest in quarters and read in part:

Subject officers are in arrest in quarters at Freeman Field Seymour Ind and in arrest in transit from Freeman Field to Godman Field Ky and upon arrival at Godman Field are placed in arrest in quarters at that station. Orders for return to this station upon completion of temporary duty will be issued by this headquarters. No per diem authorized while on this temporary duty.*
