I HEREBY ACKNOWLEDGE that I have been advised by this Court of my constitutional right to be represented by an attorney in this cause; that if I am not financially able to employ an attorney, the Court will appoint an attorney to represent me without immediate expense to me. Further, the Court has fully advised me of the charge against me, the maximum penalty involved, and my right to a trial by jury.

I desire to unconditionally waive my right to counsel. This waiver is made freely, voluntarily, and with full understanding of these rights without any promises or inducements being made to me of any nature whatsoever.

The Court having advised the defendant of his right to counsel, including the right to Court appointed counsel in the event of indigence, and the defendant having executed in open Court a Waiver of Counsel, and the Court being satisfied that the waiver is made freely, voluntarily, intelligently and with full knowledge of its consequence, it is ORDERED AND ADJUDGED that the Waiver of Counsel executed by the defendant is hereby confirmed and approved.
